



What happens to really (REALLY) old caves?

For my master's thesis, I am studying a Precambrian paleosol (soil that has turned into a rock). This paleosol is about 2.5 billion years old. It formed on a paleokarst terrain. In this terrain, there were some caves. Some of them have collapsed, which may be expected for caves that old. Others have been filled with the mineral fluorite.

The Winter Floods of 2004 Continue

It was all Jen's fault. She was the one that picked the weekend. And she claims that the rain gods hate her. So, therefore, it is her fault that southern Kentucky got 5 inches of rain that Thursday.

Some background is required here. I first met Jen at the 2003 NSS Convention where she gave a presentation on her research on crayfish. Near the end of her talk, she asked if anyone knew of caves that had crayfish. After her talk, I approached her saying that I knew of a cave with lots of crayfish. Later that year she joined me in Jugornot Cave for some biological sampling and some surveying.

In future discussions, she mentioned that she was hunting down the species line – which appeared to follow the KY and TN border, with one species north of the border and one south. I mentioned that I knew of a cave just a couple miles north of the TN border that had crayfish.

Jen chose the first weekend in February as her weekend of choice to visit Redmond. I felt that would be early enough in the winter that the threat of rain was small enough. Boy, was I wrong.

The week before, Bill Walden and I were discussing the possibility of getting into Redmond. Bill was right – there was way too much water to get in the cave.

Saturday morning, after breakfast in Bronson we headed to the cave. Along the way, Bill and I were constantly commenting on how much water there was on the surface – often enough to annoy Jen a little bit. That just caused us to say it a few more times.


As we are approaching Kay's place, we notice that the sinkhole is flooded higher than we've ever seen it. In fact, the gate to the sinkhole was almost completely under water. Once we get to the main gate, we notice that we can't take the road/stream bed to the cave as its flooded under many feet of water. So, Bill gets the key and we take the high road to the cabin where we wind up parking.

After changing into our caving clothes we were off to the cave.

It was a first time for all of us. We all saw water coming out of the main entrance of Redmond. So much for heading to the East Canyons to capture crayfish there. So we immediately continued to Stream Cave – trying to avoid getting our feet wet along the way.

We got to Stream Cave okay with only Jen getting her feet totally wet. Just inside the entrance to Stream Cave we took some time to take off layers of clothing, take pictures and warm up a little.

As we were frequently stopping to check all of the pools for crayfish, it took a good amount of time to get to where the side stream came in. But,

before we got there, we had to walk in a nearly knee deep rushing river for about a hundred feet.

Just inside the side passage, Jen found her first crayfish. She caught a total of 4 cave crayfish and at least 2 surface crayfish in Stream Cave. I caught my first cave crayfish ever – and proceeded to convince him that he didn't need one of his claws. It took me 3 tries to catch him, but I did it.

The trip out and the walk back were chilly. Jen managed to get both of her feet warm, and I got one warm, both of Bill's feet were still cold when we got back to the Cabin. As we were walking towards the dam, we see Kay walking towards his herd. Quick introductions and a short conversation followed before Kay invited us into his cabin so Bill could show off the pictures.

It was there that we learned that the water had receded many feet since Friday and that a sinkhole had opened up at the edge of his pond. (Bill says it's big enough for him to enter and wants to go back to check it out before Kay plugs it up for his pond.)

That about did it for Saturday.

Sunday morning we had breakfast at the motel and then headed out to Sloan's Valley to get some samples there. It took a while, but we did get Jen 3 samples before taking some time to take pictures at The Oasis. On the way out, we tried to get pictures near the entrance, but equipment malfunctions and fog prevented us from getting good pictures.

After a second meal at Ruby Tuesdays, Bill and I were off!



2004 NSS CONVENTION



The 2004 NSS Convention will be held July 12-16, 2004, in Marquette, Michigan. Marquette is a modern college town on the picturesque shores of Lake Superior in Michigan's Upper Peninsula. The sessions will be held on the campus of Northern Michigan University, and camping will be at the spacious Marquette County Fairgrounds.

In an effort to simplify registration, and to ensure that each person attending Convention has his or her individual needs met, the accompanier category has been eliminated. To maintain a pricing structure consistent with traditional accompaniers, we have made the guidebook optional with each registration. If you do not choose the guidebook (and why wouldn't you?) as part of registration, please select the "No Guidebook" option, and subtract the dollar amount accordingly.

Geology Field Trip - Hard Rock Sashay

The Geology Field Trip will leave the Marquette County Fairgrounds at 08:00 a.m. Sunday, July 11, 2004 on a modern air-conditioned coach. The first stop is at The Michigan Mining Industry Museum. The group will be welcomed by the Museum's Director, and a brief overview of the physical and economic geography of the area will be presented. Time will be allowed for visitation of the exhibits. We will then travel to Jasper Knob where a climb will take us to the summit of what is purported to be the "world largest gemstone," but is actually a large hill composed of a classic banded iron formation. After lunch the next stop is the Cliffs Shaft head frames where the group will tour the above ground facilities of the Cleveland Cliffs mining facilities. A large mineral collection is also displayed. The remaining stops will allow us to see sites that will take us from the Archaen Era through the Proterozoic, and into the Cambrian. We will return to the Fairgrounds in time for dinner.

Workshops

Vertical Workshop

The vertical workshop is designed to provide students with a basic overview of climbing equipment, techniques, and safety considerations for American style Single Rope Techniques. Students experience hands on sessions on knot tying, belaying, rappelling (with a rack and a bobbin,) and several ascending systems (Gibbs, Mitchell, Frog, and Prusik knot systems.) This intense workshop will give the novice climber good exposure to different systems but is not intended as a complete training course. Students will have the opportunity to use different systems in a controlled environment under instructor supervision. All participants in the Vertical Workshop need to bring a helmet, seat harness and gloves. To obtain more information, contact Terry Clark at terjen@evansville.net.

Project Underground

Project Underground is a karst education program created to help young people understand the importance of our karst resources. A variety of hands on and fun lessons lead the student to a greater appreciation of the world hidden beneath our feet. This workshop will familiarize educators with the Project Underground curriculum and teaching materials, and provide experience in using the program.
